

# **11.8 Legal Requirements for Diving Work**

## 1. POLICY / LEGISLATION SUPPORTED

- NSW Work Health & Safety Regulations 2019 Part 4.8 Diving Work

## **Overview:** The duties of a PCBU include ensuring:


- divers are medically fit and are competent through qualifications and/or experience for the type of diving work being undertaken
- a dive supervisor who has the required level of competence is appointed to supervise workers carrying out general diving work
- a dive plan is prepared by the dive supervisor, and
- a dive safety log is prepared.

Additional requirements in relation to high risk diving work include ensuring the fitness and competence of the divers and that high risk diving work is carried out in accordance with the AS/NZS: 2299.1 - 2015 Occupational diving operations – Standard operational practice

### 2. IMPLEMENTATION PRINCIPLES

#### NSW

Categorisation of Diving Work:



**Limited Diving Work:** 30metres maximum, no decompression stops, not underneath boats or structures (*not diving beneath anything that would require the diver to move sideways before being able to ascend*), not using tools that have power at surface; diving for more than 28 days during a period of 6 months.

Limited Scientific: As per above but for scientific purposes



**Incidental Diving Work:** Linked to work, such as underwater acting, supervised, and has same limitations as Limited Diving

**General Diving Work:** Diving work that is not High Risk and includes Limited / Incidental

**High Risk Diving Work:** Involves construction work, inspection work (to determine construction work is necessary), or recovery or salvage of a large structure or plant item (e.g. Vessel) for commercial purposes. High Risk does NOT include minor work in a Marina that involves cleaning, inspecting, maintaining, or searching for a vessel or mooring

**AS 4005.2** – **2000** Recreational SCUBA dive supervisor (<u>withdrawn</u>) but focusses on Training and certification of recreational SCUBA divers at a Supervisory level

**Certificate of Medical Fitness** must be issued by a medical practitioner with appropriate training in underwater medicine, and state whether or not the person is medically fit to carry out diving work
